Proposition to Organize and Establish a Sanitary District to be Known as "Lake Arispie Sanitary District" in Lake Arispie Subdivision, Bureau County, Illinois.

Shall the Board of Education of Bureau Valley Community Unit School District Number 340, Bureau, Whiteside and Lee Counties, Illinois, build and equip additions to, alter, repair, equip and improve the site of the Bureau Valley High School, including, without limitation, adding classrooms and a new gymnasium; alter, repair, equip and improve the sites of the Wyanet Elementary and Bureau Valley North school buildings, including, without limitation, improving the heating, air conditioning and ventilation systems at both buildings and replacing bleachers at the Bureau Valley North building; abate asbestos and demolish the elementary school building in Manlius; and issue bonds of said School District to the amount of \$12,000,000 for the purpose of paying the costs thereof?

BUREAU COUNTY
PROPOSITION TO IMPLEMENT A SPECIAL COUNTY
RETAILERS' OCCUPATION TAX FOR PUBLIC SAFETY

Shall Bureau County be authorized to impose a public safety tax for a law enforcement center at the rate of one-half percent upon all persons engaged in the business of selling tangible personal property at retail in the county on gross receipts from the sales made in the course of their business to be used for crime prevention, detention, and other public safety purposes? Sales of personal property titled or registered by an agency of Illinois (vehicles), food that is to be prepared and consumed off the premises (groceries), prescription and non-prescription medicines, medical devices and medical materials shall be exempt from this tax. This would mean that a consumer would pay an additional \$0.50 in sales tax for every \$100 of tangible personal property bought at retail. If imposed, the additional tax would cease being collected at the end of twenty (20) years from date of collection, if not terminated earlier by a vote of the County Board.
